Directions from Baltimore

- Take I-97 South towards Annapolis/Bay Bridge
- Merge left onto US 50 East towards Annapolis/Bay Bridge
- Take Exit 24 Rowe Blvd. (MD-70 East) towards Annapolis
- Stay in the right lane off of the exit ramp and bear right on to Rowe Blvd (MD-70 East)
- Go through 2 lights and bear to your right after the bridge past the 2nd light. Make a right at the 3rd light on to Calvert Street (you will pass the Navy Stadium on your right between the 1st and 2nd traffic lights)
- Straight ahead at the light is West St. (our office and parking is in the red brick building on the left corner of Calvert St. and West St.). Make a left into the underground parking garage in our building (entrance is marked by white "IN" lettering). Note that it is just past Gott's Parking Garage
- Proceed into the garage and take a ticket. You may do so even if there is a sign that indicates that the garage is full (we have two reserved parking spaces). Just tell the parking attendant that you are going to our office
- You will go down a ramp and bear right. On the left you will see blue signs marking the spaces for "Novotny, Larash & Grainger Client Parking"

Make a left into the underground parking garage in our building (entrance is marked by white “IN” lettering). Note that it is just past Gott’s Parking Garage).
